## CONVENTIONAL RADIATOR SUPPLY, RE-CORE, SERVICE

Consult L&M Radiator Pty Ltd (L&M) before proceeding with warranty claims or repairs. Failure to do so may void this limited warranty. This limited warranty allocates the risk of failure of the product or services between the buyer and L&M and is reflected in the purchase price.

L&M warrants that convention products will conform to L&M's written quotation.

Conventional products, supply / re-core are warranted for 12 months from date of invoice against defects in materials and workmanship during normal use.

Service and repair work are warranted for 3 months from date of invoice against defects in materials and workmanship during normal use.

L&M's liability is limited to the rework or replacement (at L&M's sole option) of the products or parts supplied by L&M that are determined by L&M to be defective in workmanship or material or do not meet L&M's quoted specification.

L&M's warranty does not apply if the product has been subject to abnormal use or conditions, unauthorized modifications or repair, corrosion, misuse, neglect, abuse, accident, improper installation, or other acts which are not the fault of L&M, including damage by shipping.

L&M does not warranty products incorporated into the supply, repair, service or re-core that are not manufactured by L&M. Buyer's sole recourse with respect to such products will be subject to the warranty of the individual manufacturer.
